CERTIFICATE OF WATER RIGHT

This Is to Certify, That HANSELL BROTHERS

of Route 1, Box 173, Hermiston 97838 , State of Oregon , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well (the source of water granted herein includes effluent from the hog raising operation)

a tributary of Umatilla River for the purpose of

irrigation of 267.0 acres

under Permit No. G-2672 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 5, 1964

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.34 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NE4 SE4, Section 27, T. 4 N., R. 27 E., W.M., 1420 feet north and 490 feet west from SE corner, Section 27.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to the use of the effluent from hog raising for irrigation is exempt from those limits and continues throughout the year as required for disposal purposes. Such waters will be impounded at times in the sewer lagoons to provide temporary system storage;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
