CERTIFICATE OF WATER RIGHT

This Is to Certify, That EDWIN H. & ETHEL J. DUYCK

of Rt. 3, Box 256, Cornelius, State of Oregon, 97113, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Reservoir constructed under Permit No. R-6123

a tributary of Council Creek for the purpose of irrigation of 109.5 acres

under Permit No. 37834 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 29, 1973 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 8.6 acre feet stored water only

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within Porter DLC 65, Section 33, T. 1 N., R. 3 W., W. M., 150 feet South and 880 feet West from the NE Corner, Section 33

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ~~of one cubic foot per second per acre~~, a diversion of not to exceed 2 $\frac{1}{2}$ acre feet for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
