CERTIFICATE OF WATER RIGHT

This Is to Certify, That . . . X. J. & CARL J. DAUENHAUER

of Rt. 1, Box 196, Dayton, State of Oregon, 97114, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Palmer Creek and reservoir constructed under Permit No. R-5108

a tributary of Yamhill River for the purpose of irrigation of 7.5 acres

under Permit No. 39060 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 8, 1974 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.09 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 17, NE $\frac{1}{4}$ NE $\frac{1}{4}$, SE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 18, all as projected within Jeffries DLC 46, T. 5 S., R. 3 W., W. M., No. 3-1080 feet North and 20 feet West from the SE Corner, Jeffries DLC 46, Reservoir-1570 feet South and 340 feet West, No. 1-2340 feet South and 810 feet West, both from the NE Corner, Jeffries DLC 46

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-5108

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.7 acre NW $\frac{1}{4}$ SW $\frac{1}{4}$
Section 17


6.8 acres NE $\frac{1}{4}$ SE $\frac{1}{4}$
Section 18

T. 5 S., R. 3 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
