## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

T. J. BOYER

of Rt. 1, Box 298, McMinnville , State of Oregon, 97128 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of South Yamhill River

a tributary of Yamhill River irrigation of 52.3 acres

for the purpose of

under Permit No. 13980 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 18, 1939 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.45 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3 (SW½ NW½), NW½ SW½, as projected within Garrison DLC 40, Section 5, T. 5 S., R. 4 W., W. M., No. 1-1450 feet South and 1260 feet East from the NW Corner, Section 4, No. 4-200 feet North and 570 feet East, No. 6-200 feet South and 70 feet West, both from the SW Corner, NW½ SW½, Section 4

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.
