CERTIFICATE OF WATER RIGHT

This Is to Certify, ThatJ. R. GOLF SERVICES, INC.
DBA: THE GOLF CLUB OF OREGON

of 905 Springhill Road, Albany, State of Oregon, 97321, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well

a tributary of Willamette River for the purpose of supplemental irrigation of 80.4 acres

under Permit No. G-6278 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 28, 1975 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.36 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within Huston DLC 71, Section 6, T. 11 S., R. 3 W., W. M., 1575 feet South and 150 feet East from the SE Corner of Thornton DLC 37.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.


A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

19.3 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$
9.5 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$
3.3 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$
