CERTIFICATE OF WATER RIGHT

This Is to Certify, That PAUL ROACH, et. al.

of P.O. Box 61, Tenmile, State of Oregon, 97481, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Tenmile Creek

a tributary of South Umpqua River for the purpose of irrigation of 13.0 acres and domestic use for one family

under Permit No. 11404 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 31, 1934

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.18 cubic foot per second, being 0.17 c.f.s. for irrigation and 0.01 c.f.s. for domestic

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (SW $\frac{1}{4}$ SW $\frac{1}{4}$), Section 31, T. 28 S., R. 7 W., W. M., 1010 feet North and 1540 feet East from the SW Corner, Section 31

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: Domestic & 4.8 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$

2.2 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$

0.8 acre Lot 4 (SW $\frac{1}{4}$ SW $\frac{1}{4}$)

5.2 acres Lot 5 (SE $\frac{1}{4}$ SW $\frac{1}{4}$)



This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered September 3, 1963 as well as to correctly describe the area of use and supersedes certificate of water right recorded at Page 14603, Volume 12, State Record of Water Right Certificates. The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
