of Rt. 1, Box 143-A, Halsey , State of Oregon, 97348 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of three natural ponds in channel of Lake Creek

a tributary of Willamette River irrigation of 102.6 acres

for the purpose of

under Permit No. 27839 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 21, 1953

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.63 cubic foot per second, measured at the point of diversion

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $\,$ NN½, NE½ SN½, both as projected within Williams DLC 38, Section 32, T. 13 S., R. 4 W., W. M., No. 1-170 feet South and 1030 feet West; No. 2-3040 feet South and 60 feet West, both from the NE Corner Williams DLC 38, NE½ NE½, as projected within Parks DLC 41, Section 5, T. 14 S., R. 4 W., W. M., No. 3-630 feet South and 2590 feet East from the SE Corner $\,^*$

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year and the right allowed hereunder shall not include the right to compel the continuance of inflow into the channel of Lake Creek of waters diverted from other sources and carried through the system of the Muddy Creeks Irrigation Project,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
