CERTIFICATE OF WATER RIGHT

This Is to Certify, That --JAMES HOLLIN

of 9292 Howell Prairie Rd., N.E., Brooks, State of Oregon, 97305 has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well

a tributary of Pudding River for the purpose of irrigation of 79.2 acres

under Permit No. G-3958 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 22, 1968 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.99 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Benet DLC 58, Section 3, T. 6 S., R. 2 W., W. M., 840 feet South and 1250 feet West from the NE Corner, Benet DLC 58

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


This certificate is issued to supersede certificate of water right recorded at Page 39902, Volume 31, State Record of Water Right Certificates so as to correctly describe the place of use.
