## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

JAMES L. ROLLIER

of Rt. 1, Box 178-R, Forest Grove , State of Oregon, 97116 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Carpenter Creek

a tributary of Tualatin River irrigation of 1.0 acre

for the purpose of

under Permit No. 18003 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 17. 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.013 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3 (SW $\frac{1}{4}$  SE $\frac{1}{4}$ ), Section 1, T. 1 S., R. 4 W., W. M., 375 feet North and 484 feet West from the SE Corner, SW $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 1

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.5 acre SW¼ SE¼ Section 1 0.5 acre NW¼ NE¼ Section 12

Both as projected within Harper DLC 41

T. 1 S., R. 4 W., W. M.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered December 16, 1975 and together with certificate of water right recorded on Page 43615, Volume 35, State Record of Water Right Certificates supersedes certificate of water right recorded on Page 20206, Volume 14, State Record of Water Right Certificates. The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
