This Is to Certify, That

GLENN MOORE

of 20220 Gooseneck Rd., Sheridan , State of Oregon, 97378 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Glenbrook Creek, unnamed drainageway and reservoir constructed under Permit No. R-6021

a tributary of Gooseneck Creek irrigation of 7.9 acres, stock and fish culture

for the purpose of

under Permit No. 37110 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 25, 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for soid purposes, and shall not exceed 0.12 cubic foot per second, being 0.10 c.f.s. for irrigation from creek and 0.01 c.f.s. for stock and 0.01 c.f.s. for fish culture from drainageway and reservoir

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3 (SW $_4$ SE $_4$), Section 32, T. 6 S., R. 6 W., W. M., creek No. 1-950 feet North and 1520 feet West; No. 2-1130 feet North and 1570 feet West; Drainageway and reservoir-750 feet North and 1320 feet West, all from the SE Corner, Section 32

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state over.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.5 acres NE¼ SE¼
2.0 acres NW¼ SE¼
0.6 acre SW¼ SE¼
0.4 acre SE¾ SE¼

All as projected within Henry Haygood DLC 50 Stock, Fish Culture & 2.4 acres Lot 3 (SW4 SE4) Stock, Fish Culture & 1.0 acre Lot 3 (SE4 SE4) Section 32

T. 6 S., R. 6 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
