a tributary of Long Tom River irrigation of 243.2 acres

for the purpose of

under Permit No. G-5122 and that said right to the use of said waters has been parfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 10, 1970

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.61 cubic feet per second, being 0.72 c.f.s. from Well No. 1 and 0.89 c.f.s. from Well No. 2

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW4 SE4, SE4 SW4, Section 11, T. 14 S., R. 5 W., W. M., No. 1-1560 feet North and 1620 feet West from the SE Corner, Section 11; No. 2-540 feet North and 1320 feet East from the SW Corner, Section 11

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,
