## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

DONALD LEICHTMAN

of 5335 NW 253rd Ave., Hillsboro, State of Oregon, 97123, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Waible Gulch, surface drain tiles and a reservoir constructed under Permit No. R-6318 a tributary of McKay Creek for the purpose of irrigation of 14.9 acres

under Permit No. 39451 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 27, 1974 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.19 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$  NW $\frac{1}{4}$  and NW $\frac{1}{4}$  NE $\frac{1}{4}$ , both as projected within Constable DLC 71, Section 21, T. 1 N., T. 2 W., W.M.; stream-10 feet West and 1000 feet South; Reservoir-50 feet East and 1030 feet South, both from the NE $\frac{1}{4}$  Corner, Section 21

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-6318

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


7.6 acres NW $\frac{1}{4}$  NE $\frac{1}{4}$   
6.3 acres SW $\frac{1}{4}$  NE $\frac{1}{4}$   
0.6 acre NE $\frac{1}{4}$  NW $\frac{1}{4}$   
0.4 acre SE $\frac{1}{4}$  NW $\frac{1}{4}$

All as projected within Constable DLC 71  
Section 21  
T. 1 N., R. 2 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
