a tributary of South Yamhill River for the purpose of log deck sprinkling, manufacturing at mill and maintenance of fire protection equipment under Permit No. 13481 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 9, 1939 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.98 cubic foot per second, being 0.77 c.f.s. for sprinkling, 0.20 c.f.s. for manufacturing and 0.01 c.f.s. for maintenance of fire protection equipment
