of Rt. 1, Box 418, Monroe , State of Oregon, 97456 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Muddy Creek

a tributary of Mary's River irrigation of 118.5 acres

for the purpose of

under Permit No. 36729 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 5, 1972

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.48 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $_3$ SW $_4$ and NW $_4$ SE $_4$, both as projected within Kelsey DLC 56, Section 20, T. 14 S., R. 5 W., W. M., No. 1-590 feet North and 470 feet East; No. 2-800 feet North and 1080 feet East; No. 3-1420 feet North and 3560 feet East, all from the SW Corner, Section 20

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
