CERTIFICATE OF WATER RIGHT

This Is to Certify, That

GEORGE W. VINCENT

of Rt. 1, Box 1506, Bandon , State of Oregon, 97411 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of two sump wells with any deficiency in the available supply from sump No. 1 to be made up by appropriation from sump No. 2 provided that the total quantity divert-* a tributary of Croft Lake for the purpose of irrigation, temperature control and harvesting cranberries of 7.5 acres

under Permit No. G-4773 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 26, 1969

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.60 cubic foot per second, being 0.19 c.f.s. for irrigation, 0.60 c.f.s. for temperature control and 0.38 c.f.s. for harvesting from Sump No. 1

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$; SE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 11, T. 30 S., R. 15 W., W. M., No. 1-1420 feet North and 3460 feet West; No. 2-640 feet North and 2920 feet West; both from the E $\frac{1}{4}$ Corner, Section 11

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre. or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year for cranberries. If for the irrigation of any other crop, this appropriation shall be limited to one-eightieth of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

In processing the application towards issuance of the permit, it appears that a clerical error was inadvertently made in limiting the duty of water for the irrigation of cranberries to not exceed 1/80th of one cubic foot per second per acre and $2\frac{1}{2}$ acre feet per acre. In the issuance of this certificate, the duty of water has been raised to 1/40th cubic foot per second per acre and 3 acre feet per acre for each acre irrigated during the irrigation season of each year, in keeping with the customary policy and determination of this office of the proper maximum limits.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
