CERTIFICATE OF WATER RIGHT

This Is to Certify, That ROY B. BOWERS & SONS, INC.

of Fort Rock, State of Oregon, 97735, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Wells No. 1 and 2

a tributary of Fort Rock Basin for the purpose of irrigation of 432.18 acres, being 203.1 acres from Well No. 1 and 229.08 acres from Well No. 2 under Permit No. G-5532 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 29, 1972 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 5.19 cubic feet per second, being 2.36 c.f.s. from Well No. 1 and 2.83 c.f.s. from Well No. 2

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the Well No. 1-Lot 2, Section 3; Well No. 2-Lot 11, Section 2, T. 26 S., R. 14 E., W. M., Well No. 1-2590 feet West and 30 feet South; Well No. 2-1330 feet East and 3100 feet South, both from the NE Corner, Section 3

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
