CERTIFICATE OF WATER RIGHT

This Is to Certify, ThatRAY DUNCAN, DONALD AND ILEANA OAKES,
ROY J. & AUDREA COX AND CHARLES &
PHOEBE REDSULLof Ironside, State of Oregon, 97909, has
a right to the use of the waters of Bridge Creek and South Fork Willow Creeka tributary of Willow Creek for the purpose of
irrigation of 391.7 acres, domestic, stock, and storage

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Malheur County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at page 258; that the priority of the right thereby confirmed dates from 1892 for irrigation of 25 acres from Bridge Creek, 1872 for 160 acres, 1873 for 40 acres, 1876 for 25 acres, 1882 for 25 acres, * that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1/40th cubic foot per second per acre until May 1st, and 1/80th cubic foot per second per acre during the remainder of the irrigation season and not to exceed 3.0 acre feet per acre per season

The point of diversion is located in the SEE BELOW

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

* 1884 for 116.7 acres from South Fork Willow Creek.


A Special Order of the Water Resources Director entered August 12, 1975 and recorded on Page 256, Volume 14, canceled 42.3 acres. This certificate is issued to confirm changes in points of diversion approved by an order of the Water Resources Director entered January 14, 1963 and supersedes certificate of water right recorded on Page 1612, Volume 2, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
