CERTIFICATE OF WATER RIGHT

This Is to Certify, That

GEORGE J. AND HERTA L. RIGGS

of 7060 Harmony Road, Sheridan, State of Oregon, 97378, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Mill Creek

a tributary of S. Yamhill River
irrigation of 12.7 acres

for the purpose of

under Permit No. 16406 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 12, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.159 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within J. Ridgeway DLC 43, Section 21, T. 6 S., R. 6 W., W. M.; 360 feet South and 1690 feet West from the NE Corner of J. Ridgeway DLC 43

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


0.7 acre NE $\frac{1}{4}$ NW $\frac{1}{4}$
4.4 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$
both as projected within Blair DLC 41
7.6 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$
as projected within J. Ridgeway DLC 43
Section 21
T. 6 S., R. 6 W., W. M.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered February 24, 1976 and together with certificate of water right recorded on Page 47759, Volume 41, State Record of Water Right Certificates supersedes certificate of water right recorded on Page 20966, Volume 15, State Record of Water Right Certificates. The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
