a tributary of West Fork Dairy Creek

for the purpose of

irrigation of 6.4 acres and supplemental irrigation of 60.9 acres

under Permit No. 36745 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.80 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE¼ SE¼, Section 25, 7. 2 N., R. 4 W., W. M., reservoir-1600 feet South and 350 feet West; spring-1530 feet South and 100 feet West, from the NE Corner, SE4 NE4, Section 25

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited tone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-5959, and shall be limited to the use of stored water only on lands described as supplemental

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Primary 0.3 acre NW14 SW14 0.5 acre SW4 SW4 Section 30 T. 2 N., R. 3 W., W. M.

Supplemental 36.3 acres SE4 NE4 24.6 acres NE4 SE1 Section 25 T. 2 N., R. 4 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
