CERTIFICATE OF WATER RIGHT

This Is to Certify, That FOREST L. & GERALDINE L. HEMEON

of Mist, State of Oregon, 97016, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Nehalem River and a spring

a tributary of Pacific Ocean for the purpose of domestic use for two families including the irrigation of lawn and garden not to exceed $\frac{1}{2}$ acre in area, and stock under Permit No. 39824 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 20, 1974

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second, being 0.005 c.f.s. for stock and 0.01 c.f.s. for domestic from river and 0.005 c.f.s. for stock and 0.01 c.f.s. for domestic from spring

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 5 (NW $\frac{1}{4}$ SW $\frac{1}{4}$), Lot 6 (NE $\frac{1}{4}$ SW $\frac{1}{4}$), Section 14, NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 23, T. 6 N., R. 5 W., W. M., No. 1-1540 feet North and 120 feet East; No. 2-2150 feet North and 1400 feet East; spring-180 feet South and 740 feet East, all from the SW Corner, Section 14

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ----- of one cubic foot per second per acre,

Any deficiency in the available supply from the spring may be made up by appropriation from the Nehalem River providing that the total quantity diverted from both sources for westerly one domestic use and connected stock supply shall not exceed 0.015 c.f.s.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Domestic & Stock Lot 6 (NE $\frac{1}{4}$ SW $\frac{1}{4}$)
 Stock Lot 5 (NW $\frac{1}{4}$ SW $\frac{1}{4}$)
 Domestic & Stock Lot 10 (SW $\frac{1}{4}$ SW $\frac{1}{4}$)
 Section 14
 T. 6 N., R. 5 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
