and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson

County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 4, at page 1; that the priority of the right thereby confirmed dates from 1859 for 0.275 c.f.s. for irrigation of 18.95 acres and 1887 for 0.246 c.f.s. for the irrigation of 17.05 acres in Tract No.1\* that the amount of water to which such right is efficient, for the purposes aforecast, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.521 cubic foot per second for Tract No. 2

The point of diversion is located in the NE's NE's, Section 30, T. 35 S., R. 5 W., W. M., McDonough Ditch-100 feet North and 450 feet West from the SE Corner, NE's NE's, Section 30
