CERTIFICATE OF WATER RIGHT

This is to Certify, That **Newton Robertson**

of **Monument**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

**COTTONWOOD CREEK**, a tributary of **JOHN DAY RIVER**, for the purpose of irrigation of 62 acres under Permit No. **3638** of the State Engineer, and that his right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **December 9, 1917**;

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.78 cubic feet per second, or its equivalent in case of rotation.**

The use hereunder for irrigation shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent in case of rotation.

A description of the lands irrigated under the right hereby confirmed, and to which such right is appurtenant (or, if for other purposes, the place where the water is put to beneficial use), is as follows:

Twenty-two acres in the Southeast quarter of Northeast quarter; eleven acres in the Southwest quarter of Northeast quarter; twenty-one acres in the Northeast quarter of Southeast quarter; six acres in the Northwest quarter of Southeast quarter of Section Twelve, Township Nine South, Range Twenty-seven East of Willamette Meridian; and two acres in the Southwest quarter of Southwest quarter of Section Seven, Township Nine South, Range Twenty-eight East of Willamette Meridian, all in Grant County, Oregon.

**NOTE:** This certificate is issued to correct and supersede that certain certificate issued to Newt Robertson, of Monument, Oregon, on June 4th, 1919, and recorded in State Record of Water Right Certificates Volume 3, Page 2344, and on page 481, Volume "C" Record of Water Right Certificates of Grant County, said former certificate having erroneously described the land actually irrigated under the above Permit No. 3638 of the State Engineer.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby confirmed and limited.
