## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That**

VIRGIL &amp; ALLEN MATHANY

of 11600 Staats Rd., Monmouth, State of Oregon, 97361, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Luckiamute River

a tributary of Willamette River for the purpose of irrigation of 51.4 acres

under Permit No. 24720 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 26, 1957

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.64 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$  NW $\frac{1}{4}$ , SE $\frac{1}{4}$  NW $\frac{1}{4}$ , both as projected within Zumwalt DLC 49, Section 25, T. 9 S., R. 6 W., W. M., No. 1-2000 feet North and 870 feet West; No. 2-800 feet North and 1170 feet West; both from the SE Corner, Zumwalt DLC 49

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.4 acres NW $\frac{1}{4}$  NE $\frac{1}{4}$

1.6 acres SW $\frac{1}{4}$  NE $\frac{1}{4}$

27.0 acres NE $\frac{1}{4}$  NW $\frac{1}{4}$

20.4 acres SE $\frac{1}{4}$  NW $\frac{1}{4}$

All as projected within Zumwalt DLC 49



This certificate is issued to confirm an additional point of diversion approved by an order of the Water Resources Director entered May 17, 1977 and supersedes certificate of water right recorded on Page 26579, Volume 18, State Record of Water Right Certificates. The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
