## CERTIFICATE OF WATER RIGHT

This Is to Certify, That P. KENDALL CATES

of 17170 Maple Grove Rd., Monmouth, State of Oregon, 97361, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Luckiamute River

a tributary of Willamette River for the purpose of irrigation of 7.8 acres

under Permit No. 19015 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 30, 1949 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.10 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (SE $\frac{1}{4}$  NE $\frac{1}{4}$ ), Section 26, T. 9 S., R. 6 W., W. M., 2380 feet South and 700 feet West from the NE Corner, Section 26

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.6 acres SW $\frac{1}{4}$  NE $\frac{1}{4}$ 1.2 acres SE $\frac{1}{4}$  NE $\frac{1}{4}$ 

Both as projected within J. Zumwalt DLC 49  
Section 26

T. 9 S., R. 6 W., W. M.

Land on which water is to be used is a part of that described as follows; N $\frac{1}{2}$  SW $\frac{1}{4}$  NE $\frac{1}{4}$  lying North of the River, W $\frac{1}{4}$  SE $\frac{1}{4}$  NE $\frac{1}{4}$  lying North of Luckiamute River, all in Section 26, Township 9 South, Range 6 West, W.M.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered May 31, 1977 and supersedes certificate of water right recorded on Page 21090, Volume 15, State Record of Water Right Certificates. The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
