CERTIFICATE OF WATER RIGHT

This Is to Certify, That IRL DAVIS, JR.

of Rt. 1, Box 53, Tygh Valley, State of Oregon, 97063, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Well No. 2

a tributary of Pine Hollow Creek for the purpose of domestic use for 202 families including the irrigation of lawns and gardens not to exceed $\frac{1}{2}$ acre in area for permanent homes, domestic use for 19 space trailer* under Permit No. G-5032 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 4, 1970 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.38 cubic foot per second, being 0.25 c.f.s. for domestic use and 0.13 c.f.s. for irrigation

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 4, T. 4 S., R. 12 E., W. M., 408 feet North and 1410 feet West from the SE Corner, Section 4

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


