of Rt. 1, Box 269, Woodburn , State of Oregon, 97071 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Bill Rose Reservoir constructed under Permit No. R-5821

a tributary of Rock Creek for the purpose of irrigation of 291.3 acres and supplemental irrigation of 18.8 acres

under Permit No. 39823 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 10. 1974

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 339.3 acre feet stored water only

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE4 SE4, Section 17, T. 5 S., R. 1 E., W. M., 1220 feet North and 1220 feet West from the SE Corner, Section 17

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to -----of-one-cubic-foot-per-second per-axe, a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
