CERTIFICATE OF WATER RIGHT

This Is to Certify, That CON DOHERTY

of Box 656, Pilot Rock, State of Oregon, 97868, has made proof to the satisfaction of the Water Resources Director of a right to the use of the waters of two reservoirs constructed under Permit No. R-5352

a tributary of Gurdane Creek for the purpose of supplemental irrigation of 43.4 acres

under Permit No. 33802 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 7, 1968

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.38 acre feet stored water only, being 0.99 a.f. from reservoir No. 1 and 2.39 a.f. from reservoir No. 2

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$, NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 32, T. 3 S., R. 30 E., W. M., Reservoir No. 1-2620 feet South and 1080 feet East; Reservoir No. 2-3000 feet South and 880 feet East, both from the NW Corner, Section 32

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ~~of one cubic foot per second per acre~~ a diversion of 4 acre feet for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

21.5 acres NE $\frac{1}{4}$ NE $\frac{1}{4}$

5.4 acres SE $\frac{1}{4}$ NE $\frac{1}{4}$

Section 31

8.9 acres NW $\frac{1}{4}$ NW $\frac{1}{4}$

7.6 acres SW $\frac{1}{4}$ NW $\frac{1}{4}$


