CERTIFICATE OF WATER RIGHT

This Is to Certify, That THOMPSON CREEK IRRIGATION ASSOCIATION

of 5777 Thomas Creek Rd., Applegate, State of Oregon, 97530, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Big Miller Lake Reservoir constructed under Permit No. R-4929

a tributary of Miller Creek for the purpose of supplemental irrigation of 978.2 acres

under Permit No. 32253 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 28, 1961

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 57.6 acre feet stored water only

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 NW 1/4, Section 28, T. 40 S., R. 5 W., W. M., South 58 degrees East 1980 feet from the NW Corner, Section 28

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to -----of one-cubic-foot-per-second per-acre, a diversion of 4 1/2 acre feet for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
