## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

LEWIS HAGELSTEIN & DOROTHY BUCHANAN

of Rt. 5, Box 1251, Klamath Falls , State of Oregon, 97601 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Upper Klamath Lake

a tributary of Klamath River for the purpose of irrigation of 240.0 acres and supplemental irrigation of 65.4 acres

under Permit No. 40926 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 2, 1976

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid is limited to an amount actually beneficially used for said purposes, and shall not exceed 7.6 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 18, T. 37 S., R. 9 E., W. M., and Lot 2 (SW $\frac{1}{4}$  NE $\frac{1}{4}$ ), Section 13, T. 37 S., R. 8 E., W. M., 1500 feet South and 500 feet West from the N $\frac{1}{4}$  Corner, Section 18; 2950 feet North and 2400 feet West from the SE Corner, Section 13

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
