## CERTIFICATE OF WATER RIGHT

of Rt. 3, Box 541, Corvallis , State of Oregon, 97330 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Willamette River and Lake Creek

a tributary of Columbia River irrigation of 199.5 acres

Permit A-2-2M-5/77

for the purpose of

under Permit No. 38108 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 14. 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.50 cubic feet per second, being 1.85 c.f.s. from Willamette River and 0.65 c.f.s. from Lake Creek

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $_4$  SE $_4$ , as projected within Watts DLC 43, Section 19, SE $_4$  SW $_4$ , as projected within Watts DLC 43, Section 20, T. 13 S., R. 4 W., W. M., River-1710 feet South and 350 feet East from the NW Corner, Watts DLC 43, Creek-680 feet North and 420 feet West from the S $_4$  Corner, Section 20

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
