CERTIFICATE OF WATER RIGHT

This Is to Certify, That ROBERT L. STOCKHOFF

of 37990 Gilkey Rd., Scio, State of Oregon, 97374, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Thomas Creek

a tributary of South Santiam River for the purpose of irrigation of 25.0 acres

under Permit No. 21393 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 20, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.313 cubic foot per second, if available at the original point of diversion; NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 22, T. 10 S., R. 2 W., W. M., 950 feet South and 900 feet West from the NE Corner, Section 22

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 9 (SW $\frac{1}{4}$ SE $\frac{1}{4}$), Section 15, T. 10 S., R. 2 W., W. M., 5680 feet North and 950 feet West from the SE Corner, Calavan DLC 65

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.2 acres NE $\frac{1}{4}$ NE $\frac{1}{4}$
0.2 acre NW $\frac{1}{4}$ NE $\frac{1}{4}$
1.0 acre SW $\frac{1}{4}$ NE $\frac{1}{4}$
14.2 acres SE $\frac{1}{4}$ NE $\frac{1}{4}$
8.4 acres NE $\frac{1}{4}$ SE $\frac{1}{4}$



This certificate is issued to confirm an additional point of diversion approved by an order of the Water Resources Director entered August 29, 1977 and supersedes certificate of water right recorded on Page 21332, Volume 15, State Record of Water Right Certificates. The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
