## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

WILLIAM E. & MARY GAIL BLACKABY

of P.O. Box 280, Ontario , State of Oregon, 97914 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a drain ditch and Snake River

a tributary of Columbia River irrigation of 10.7 acres

for the purpose of

under Permit No. 40783 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 6, 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.27 cubic foot per second, water to be diverted from drain ditch when available with any deficiency in the available supply from the drain ditch to be made up by appropriation from Snake River provided further that the total \*

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 6 (SW $_4$  SW $_4$ ), Lot 5 (SE $_4$  SW $_4$ ), Section 15, T. 18 S., R. 47 E., W. M., 950 feet North and 1100 feet East; 800 feet North and 1550 feet East, both from the SW Corner, Section 15

The amount of water vsed joe irrigation, together with the amount secured under any other right existing for the same lands, stall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 acre feet per acre for each acre irrigated during the irrigation season of each year, and shall be also limited to the water available at the proposed point of diversion, and shall not carry with it the right to compel the continuance of the waste water.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.4 acre NE4 SW4 0.3 acre NW4 SW4 7.3 acres Lot 6 (SW4 SW4) 2.7 acres Lot 5 (SE4 SW4) Section 15 T. 18 S., R. 47 E., W. M.

\* quantity of water diverted from both sources shall not exceed 0.27 c.f.s.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
