## CERTIFICATE OF WATER RIGHT

of 19124 Old Mehama Rd., Stayton , State of Oregon, 97383 proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of North Santiam River and Detroit Reservoir constructed under Permit No. R-1625

a tributary of Santiam River irrigation of 21.6 acres

for the purpose of

and that said right to the use of said waters has been perfected in under Permit No. 39478 accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 4, 1975

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.27 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the River-Lot 1 (NE $\frac{1}{4}$  NE $\frac{1}{4}$ ), Section 22, T. 9 S., R. 1 E., W. M., 210 feet South and 70 feet West from the SE Corner, Section 15; Reservoir-Lot 2 (SW $\frac{1}{4}$  NW $\frac{1}{4}$ ), Section 7, T. 10 S., R. 5 E., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1625, and is subject to the terms and conditions of contract No. 14-06-100-8849 or a satisfactory replacement between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the Water Resources Department,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> 2.1 acres Lot 6 (NW4 SW4) 9.4 acres Lot 4 (SW4 SW4) Section 14 10.0 acres Lot 5 (SE¼ SE¼) Section 15 0.1 acre Lot 1 (NE¼ NE¼) Section 22 T. 9 S., R. 1 E., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
