under Permit No. G-6009 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 21, 1975

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.67 cubic feet per second, being 1.0 c.f.s. from Well No. 4, 0.23 c.f.s. from Well No. 2, and 0.44 c.f.s. from Well No. 1

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SW4 SW4, SE4 SW4, Section 1, T. 9 S., R. 4 W., W. M., Well No. 4-1320 feet North and 1320 feet East; Well No. 2-960 feet North and 680 feet East; Well No. 1-390 feet North and 1900 feet East, all from the SW Corner, Section 1

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
