## CERTIFICATE OF WATER RIGHT

This Is to Certify, That RICHARD KIRKHAM

of 9225 Steel Bridge Rd., Willamina, State of Oregon, 97396, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of South Yamhill River

a tributary of Yamhill River for the purpose of irrigation of 72.4 acres

under Permit No. 40025 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 23, 1975

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.90 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{2}$  NW $\frac{1}{4}$ , Section 6, T. 6 S., R. 6 W., W. M., No. 1-3300 feet North and 2100 feet East from the SW Corner, Section 6; NE $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 12, T. 6 S., R. 7 W., W. M., No. 2-620 feet South and 160 feet West from the NE Corner, Section 12

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


