that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.00 cubic foot per second, if available at the original point of diversion; SW4 NW4, as projected within E. Liggetts DLC 52, Section 18, T. 12 S., R. 5 W., W. M., South 30 degrees 28 minutes East 26.2 chains from the NW Corner, E. Liggetts DLC *

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $_4$, as projected within E. Liggetts DLC 52, Section 18, T. 12 S., R. 5 W., W. M., 1840 feet South and 630 feet East from the NW Corner, E. Liggetts DLC 52

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
