## CERTIFICATE OF WATER RIGHT

This Is to Certify, That JOE TEIXEIRA

of Argo Rt., Box 8-A, Myrtle Point, State of Oregon, 97458, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Coquille River

a tributary of Pacific Ocean for the purpose of irrigation of 94.0 acres and dairy use

under Permit No. 41716 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 15, 1977 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.19 cubic feet per second, being 1.18 c.f.s. for irrigation and 0.01 c.f.s. for dairy use

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (SW $\frac{1}{4}$  NE $\frac{1}{4}$ ), Section 5, T. 29 S., R. 12 W., W. M., 920 feet North and 80 feet East from the C $\frac{1}{4}$  Corner, Section 5.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


- 16.9 acres Lot 4 (SW $\frac{1}{4}$  NE $\frac{1}{4}$ )
- 2.0 acres Lot 3 (SE $\frac{1}{4}$  NW $\frac{1}{4}$ )
- 3.0 acres NE $\frac{1}{4}$  SW $\frac{1}{4}$
- 1.8 acres Lot 5 (NE $\frac{1}{4}$  SE $\frac{1}{4}$ )
- 39.5 acres NW $\frac{1}{4}$  SE $\frac{1}{4}$
- Dairy Use & 15.2 acres SW $\frac{1}{4}$  SE $\frac{1}{4}$
- 15.6 acres Lot 6 (SE $\frac{1}{4}$  SE $\frac{1}{4}$ )

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
