CERTIFICATE OF WATER RIGHT

a tributary of Columbia River irrigation of 252.7 acres

for the purpose of

under Permit No. 3163 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 23, 1916

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.16 cubic feet per second

or its equivalent ir case of rotation, measured at the point of diver ion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 26, T. 13 S., R. 29 E., W. M., 740 feet South and 3360 feet West from the NE Corner, Section 26

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be limited to a diversion of not to exceed 1 acre foot per acre for each acre irrigated during any month prior to July 1 and shall be further limited to a total diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season from April 1 to about July 1 of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered February 15, 1977 and together with certificate of water right recorded on Page 46261, Volume 38, State Record of Water Right Certificates supersedes certificate of water right recorded on Page 24504, Volume 17, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
