## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** DALE LEE WOODWARD

of 4660 Payne Rd., Medford, State of Oregon, 97501, has  
a right to the use of the waters of Anderson Creek

a tributary of Bear Creek for the purpose of  
irrigation of 7.0 acres, domestic, and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 4, at page 1; that the priority of the right thereby confirmed dates from 1857

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.09 cubic foot per second, if available at the original point of diversion, Baldwin Ditch

The point of diversion is located in the NE $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 33, NW $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 34, T. 38 S., R. 1 W., W. M., Baldwin Ditch-South 30 degrees West 570 feet; Pump-150 feet South and 120 feet East, both from the W $\frac{1}{4}$  Corner, Section 34

A description of the place of use under the right, and to which such right is appurtenant, is as follows:


This certificate describes that portion of the water right confirmed by the prior certificate recorded at Page 16078, Volume 13, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on January 3, 1978, approving transfer application No. 2537 and is issued to confirm a change in point of diversion approved by the same order.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
