## CERTIFICATE OF WATER RIGHT

a tributary of Willamette River irrigation of 271.6 acres

for the purpose of

under Permit No. G-5231 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 17, 1972

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.0 cubic feet per second, total quantity from both wells at any one time

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SW½, Section 5, NW½, NE½, Section 7, both as projected within Rive DLC 39, T. 5 S., R. 2 W., W. M., Well No. 2-290 feet North and 10 feet East; Well No. 1-520 feet South and 2350 feet West, both from the NE Corner Section 7

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
