A special order was entered on September 2, 1964 which canceled the right to the use of 4.0 cubic feet per second of the waters of Fifteen Mile Creek for development of power to run feed mill and general ranch use. This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered September 4, 1964 and supersedes certificate of water right recorded at page 5647, Volume 6, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
