CERTIFICATE OF WATER RIGHT

This Is to Certify, That CALVIN E. VAN DER VEEN

of Rt. 2, Box 242, McMinnville, State of Oregon, 97128, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Baker Creek

a tributary of North Yamhill River for the purpose of irrigation of 13.9 acres

under Permit No. 17622 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 19, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.17 cubic foot per second, if available at the original point of diversion; SW 1/4 NW 1/4, Section 13, T. 4 S., R. 5 W., W. M., 2150 feet South and 360 feet East from the NW Corner, Section 13.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 NW 1/4, as projected within Dawson DLC 43, Section 13, T. 4 S., R. 5 W., W. M., 1710 feet North and 1340 feet West from the SE Corner, Dawson DLC 43

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 0.9 acre NE 1/4 NW 1/4
- 11.9 acres NW 1/4 NW 1/4
- 1.1 acres SW 1/4 NW 1/4

All as projected within Dawson DLC 43 Section 13 T. 4 S., R. 5 W., W. M.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered December 12, 1975 and supersedes certificate of water right recorded at Page 22165, Volume 16, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
