CERTIFICATE OF WATER RIGHT

This Is to Certify, That J. PAUL WILEY

of Broadbent, State of Oregon, 97414, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of South Fork Coquille River

a tributary of Coquille River for the purpose of irrigation of 31.66 acres

under Permit No. 13851 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 21, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.40 cubic foot per second, if available at the original point of diversion; Lot 8 (SW $\frac{1}{4}$ NE $\frac{1}{4}$), Section 28, T. 29 S., R. 12 W., W. M., North 17 degrees 15 minutes East, 3498 feet from the S $\frac{1}{2}$ Corner, Section 28

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 7 (NE $\frac{1}{4}$ SW $\frac{1}{4}$), Section 28, T. 29 S., R. 12 W., W. M., 1080 feet South and 780 feet West from the C $\frac{1}{2}$ Corner, Section 28

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.26 acres NE $\frac{1}{4}$ SE $\frac{1}{4}$
29.40 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$
Section 28
T. 29 S., R. 12 W., W. M.


This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered April 15, 1965 and together with certificate of water right recorded at Page 48226, Volume 41, State Record of Water Right Certificates supersedes certificate 14239.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
