CERTIFICATE OF WATER RIGHT

This Is to Certify, That R. H. EMMERSON & SON

of P.O. Box 130, Arcata, State of California, 95521, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Little Crane Creek and North Branch Little Crane Creek and Hunter Reservoir constructed under Permit No. R-4580 a tributary of Crane Creek for the purpose of irrigation of 95.6 acres and supplemental irrigation of 26.4 acres

under Permit No. 30444 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 14, 1961 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.05 cubic feet per second, being 1.55 c.f.s. from Little Crane Creek and 0.5 c.f.s. from North Branch Little Crane Creek

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 27, NW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 28, NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 34, T. 24 S., R. 35 E., W. M., reservoir-1050 feet South and 400 feet East; Diversion No. 1-1080 feet South and 1620 feet West, both from the NE Corner, Section 28; Diversion No. 2-250 feet South and 300 feet East from the NW Corner, Section 34

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-4580 and shall be further limited to the use of stored water only on the lands described as supplemental, and is subject to the terms and conditions of an order dated June 26, 1965 and recorded on pages 233A and 233B, Volume 14, Special Order Record of the Water Resources Director, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


