## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** ROBERT S. GRIFFIN

of P.O. Box 404, Bandon, State of Oregon, 97411, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean for the purpose of irrigation of 17.1 acres

under Permit No. 30060 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 23, 1964 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.21 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 5 (SE $\frac{1}{4}$  SW $\frac{1}{4}$ ), Lot 6 (NE $\frac{1}{4}$  SW $\frac{1}{4}$ ), Section 29, T. 35 S., R. 1 W., W. M., No. 1-1300 feet North and 1940 feet East; No. 2-1960 feet North and 1870 feet East, both from the SW Corner, Section 29

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:



This certificate describes that portion of the water right confirmed by the prior certificate recorded at Page 35467, Volume 27, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on November 4, 1975, approving transfer application No. 3094, as well as to confirm a change in point of diversion approved by the same order. The issuance of this superseding certificate does not confirm the status of the water right in reference to QRS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
