CERTIFICATE OF WATER RIGHT

of 18252 Redwood Highway, Selma , State of Oregon, 97538 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Clear Creek

a tributary of Illinois River irrigation of 1.0 acre

for the purpose of

and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 27, 1933 for 0.013 c.f.s. and June 8, 1933 for 0.007 c.f.s. that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second, if available at the original point of diversion; SE4 SW4, Section 2, T. 38 S., R. 8 W., W. M., 230 feet North and 650 feet West from the N4 Corner, Section 11

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 11, T. 38 S., R. 8 W., W. M., 1420 feet North and 1240 feet West from the Center, Section 11.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fiftieth of one cubic foot per second per acre, or its equivalent for each acre irrigated throughout the irrigation season from April 1, to November 1 of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.0 acre NE¼ NW¼ Section 11 T. 38 S., R. 8 W., W. M.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered December 18, 1972 and together with certificates of water right recorded at Page 48253, Volume 41 and Page 39239, Volume 31, State Record of Water Right Certificates supersedes certificate of water right recorded at Page 12241, Volume 11, State Record of Water Right Certificates. The issuance of this superseding certificate does not confirm the status or the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
