that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shell not exceed 0.18 cubic foot per second, if available at the original point of diversion; NW4, NW4, Section 4, T. 35 S., R. 5 W., W. M., 1250 feet South and 320 feet East from the NW Corner, Section 4

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE4 NE4, Section 5, T. 35 S., R. 5 W., W. M., 1220 feet South and 330 feet West from the NE Corner, Section 5

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4½ acre feet per acre for each acre irrigated during the irrigation season of each year, and is subject to a stipulation with the Oregon State Game Commission recorded at Page 52 and 53, Volume 4, Miscellaneous Records of the Water Resources Department.

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

T. 35 S., R. 5 W., W. M. This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered May 17, 1977 and together with certificate of water right recorded on Page 44961, Volume 37, Late Record of Water Right Certificates supersedes certificate of water right recorded on Page 41610, Volume 33, State Record of Water Right Certificates. The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place

of use herein described and is subject to the existing minimum flow policies established by the

Water Policy Review Board.
