that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 10.0 cubic feet per second, being 0.8 c.f.s. for pond loss; 9.2 c.f.s. for industrial use and fire protection, if available at the original point of diversion; SE4 NW4, Section 26, T. 13 S., R. 1 E., W. M., 3255 feet North and * or its equivalent in case of rotation, measured at the point of diversion from the stream.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purpose aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
