CERTIFICATE OF WATER RIGHT

of Box 168, Rt. 2, Silverton , State of Oregon, 97381 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Pudding River

a tributary of Molalla River irrigation of 12.9 acres

for the purpose of

under Permit No. 14630 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 25, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.161 cubic foot per second, if available at the original point of diversion; Lot 1 ($NE_4^LNW_4^L$), Section 29, T. 6 S., R. 1 W., W. M., 960 feet South and 650 feet West from the N_4^L Corner, Section 29

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1_4 NW 1_4 , as projected within Smith DLC 42, Section 29, T. 6 S., R. 1 W., W. M, 10 feet South and 2530 feet East from the NE Corner, Lot 1 (NE 1_4 NE 1_4), Section 30

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered April 11, 1966 and together with certificate of water right recorded at Page 33901, Volume 25, State Record of Water Right Certificates supersedes certificate of water right recorded at Page 15441, Volume 13, State Record of Water Right Certificates. The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
