## CERTIFICATE OF WATER RIGHT

of Hwy. 101-S, Brookings , State of Oregon, 97415 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of seven wells

a tributary of McVay Creek for the purpose of supplemental irrigation of 24.7 acres and temperature control

under Permit No. G-5640 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 8, 1970

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.31 cubic feet per second: Irrigation - 0.31 cubic foot per second, being 0.077 c.f.s. from each of wells numbered 4 - 7; temperature control - 1.00 cubic foot per second, being 0.143 c.f.s. from each of wells number 1 - 7.

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NE½ NE½, Section 16, NW½ NW½, as projected within 0'Loughlin DLC 42, NW½ NW¼, as projected within Johnson DLC 43, Section 15; T. 41 S., R. 13 W., W. The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
